**Minutes of the meeting of the DPAC regarding Sports infrastructure under Khelo India Scheme**

The meeting of Departmental Project Approval Committee (DPAC) of the "Utilization and Creation/up-gradation of Sports Infrastructure" component of Khelo India National Programme for Development of Sports Scheme was held on 28.06.2019 at 11.00 Hrs. under the Chairmanship of Shri R.S. Julaniya, Secretary (Sports), MYAS in Room No. 3 'C' Wing, Shastri Bhawan, New Delhi. The list of participants is annexed.

2. The DPAC was apprised that as per interim Budget Allocation, Rs. 247.90 crore has been allotted as Grants for Creation of Capital Assets out of total budget allocation of Rs. 500 crore. At present, Rs. 179.31 crore is available for funding infrastructure projects.

3. Thereafter, the Agenda Items were considered by DPAC and decisions taken as under:-

(i). **Agenda Item No. 1: Approval of new projects under Khelo India Scheme:-**

Out of 13 proposals given in Table A of the Annexure to the Agenda, the DPAC approved the following proposals:-

(iii). **Additional Agenda Item No. 1:- Construction of four 300 Bedded Hostels at SAI Regional Centres - revised estimates.**

DPAC approved the revised estimates of Rs. 126.96 crore for construction of four 300 Bedded Hostels at SAI Regional Centres Bhopal, Sonapat, Imphal and LNCPE Trivendrum, in view of the justification provided by Sports Authority of India

(iv) **Additional Agenda Item No. 2:- Construction of 10 numbers 300 Bedded Hostels at Sports Authority of India (SAI) Stadia/ Centres.**

DPAC approved the proposal of construction of ten 300 Bedded Hostels for sports persons at the following places at a total cost of Rs. 267.70 crore:-

- (i) Jawaharlal Nehru Stadium, New Delhi
- (ii) Indira Gandhi Stadium, New Delhi
- (iii) Dr. Karni Singh Shooting Range, Tughlakabad, New Delhi
- (iv) SAI Training Centre, Aurangabad
- (v) SAI NSNIS- Patiala
- (vi) Regional Centre, Lucknow
- (vii) Regional Centre, Kolkata
- (viii) Regional Centre, Bangalore
- (ix) SAI Training Ccentre, Dharamshala
- (x) ASI Pune

(v) **Additional Agenda Item No. 3:- Sanction of financial assistance of Rs. 2.98 crore for construction of Sports Infrastructure in New Moti Bagh Complex, Chankyapuri, New Delhi.**

DPAC approved the proposal for grant of financial assistance of Rs. 2.98 crore for construction of Sports Infrastructure in New Moti Bagh Complex, Chankyapuri, New Delhi to facilitate spread of the sports culture by bridging infrastructure gap. It was decided that execution of the entire project may be assigned to SAI. It was also decided that SAI may enter into an MoU with Residential Welfare Association, New Moti Bagh Complex that the facilities created with this grant will be open for use by General Public.

(vi) **Other decisions:- (a) Construction of Wrestling Hall at SAI Regional Centre Lucknow:-**The DG-SAI informed that a proposal for construction of Wrestling Hall at SAI Regional Centre Lucknow at an estimated cost of Rs. 8.00 crore under Khelo India Scheme has been submitted to the Ministry with full justification along with all required documents and requested that the same may also be considered. The DPAC approved the proposal.

(b) **Provision of Gymnasium equipment for National Hockey Academy at Major Dhyanchand National Stadium, New Delhi :-** An amount of Rs. 1.50 crore was approved in principal by the DPAC for Gymnasium equipment for National Hockey Academy at Major Dhyanchand National Stadium, New Delhi.
