Agenda Item No. 1: Appointment of Project Management Unit (PMU) on NICS I Rate Contract

Reference is invited to the limited tender for Appointment of Project Management Unit (PMU) on NICS I Rate Contract for SAI against IFS No: F. No. 30/FIT INDIA MISSION/RFP/2019-20. A limited tender enquiry was issued to the following NICS I empanelled agencies:

1. Deloitte Touche Tohmatsu India LLP
2. Ernst & Young LLP
3. KPMG
4. Price Water House Coopers P Ltd.
5. Wipro Limited

Based on the scores of technical cum presentation evaluation, the committee recommended that bid of M/s Ernst & Young LLP may be accepted being the highest in technical cum presentation evaluation.

Approval of the Departmental Project Approval Committee is hereby solicited for approval of Award of Work to M/s Ernst & Young LLP for setting up of PMU in SAI for an initial period of 12 months at the approved rates of NICS I bearing total financial implication of ₹ 4,78,66,464/- (INR Four Crores Seventy Eight Lakhs Sixty Six Thousand Four Hundred and Sixty Four Only).

Agenda Item No. 2: Setting up of Project Management Unit (PMU) for NSRS:

As per the minutes dated 29.11.2019 issued from Prime Minister's Office for the meeting chaired by Hon'ble PM in which it was desired that under "Guru Shishya Parampara", Department of Sports should have an online portal on which all coaches (Gurus) could register themselves with details of their students (Shishyas), with necessary details.

In order to achieve this, NSRS (National Sports Repository System) is envisaged to prepare a comprehensive digital platform with a vision to create a central databank of all sports stakeholders concerned replicating Guru Shishya model to create a central data bank for linking the coach (Guru) who identified the raw talent and all other coaches who contributed successively in the career path of an athlete (Shishya) right from identifying the raw potential and then nurturing him to make of the budding talent. Further, as per the Gazette Notification of Khelo India it was proposed to develop a comprehensive portal for Community coaching, school fitness, talent search and Development, Sports Infrastructure including Playfields etc. to be developed to enable effective reporting and monitoring.

NSRS as a centralized system has been conceptualized, which links all the stakeholders and entities of sports such as Athletes, Coaches, National Centres of Excellence and Academies etc. It will have the functionality and comprehensive digital solution for Talent Identification and Development through their admissions in various Academies/NCOEs. Further, Fit India Movement has given a great impetus to Fitness Assessment of school going children. The fittest children will provide an opportunity to identify the raw potential talent. The fitness assessment portal shall be linked with NSRS for identifying and nurturing of the raw potential talent. Under Khelo India, it is also envisaged that identification of sporting talents through different avenues, including through advance scientific profiling, shortlisting of talents and recommending the best talent for providing the support. Khelo India yearmarked Rs. 10 Crore annually for maintenance of such online portal.

In order to successfully develop and maintain NSRS there is a need to set up a **Project Management Unit (PMU)** consists of Technical Professionals/Developers. It is proposed to set up the PMU through NICS empanelled agencies (Tier-3). The agency may be engaged for a period of 01 year initially extendable for 01 more year. The tentative estimates for engaging agency for setting up of PMU is Rs. 2.30 Crores for 02 years, however, due to the evolving nature of NSRS this may go upto Rs. 4.0 Crores.

Administrative approval from the Departmental Project Approval Committee is solicited for approval of setting up of PMU for NSRS at tentative cost of Rs. 4.0 Crores (Rupees Four Crores Only).

Agenda Item No. 3: Proposal from Basketball Federation of India for Under-17 Girls National Basketball League under Khelo India Scheme

A proposal has been received from the Basketball Federation of India requesting support for the conduct of the U17 Girls National Basketball League in collaboration with Khelo India.

The copy of the letters received from Basketball Federation of India is placed at **Annexure 1-A**. The proposed League structure shall be divided into the following two stages:

- a) Round 1 between Local Clubs/Academies/School teams in 21 cities of States/UTs identified across the country.
- b) Round 2: Final Round at one centralized venue between higher-ranked teams of each Round 1 group.

For the conduct of the above-mentioned League, the Basketball Federation of India has requested funds as support for an amount of **Rs. 1,01,64,000/- (Rupees One Crore One Lakh Sixty four Thousand only)** with the detailed break-up of costs for the organizing and conduct placed at **Annexure 1-B**.

Approval of the Departmental Project Approval Committee is hereby solicited for providing funds for an amount of Rs. 1,01,64,000/- (Rupees One Crore One Lakh Sixty four Thousand only) for the proposal received from the Basketball Federation of India for the conduct of U17 Girls National Basketball League under Khelo India Scheme.

Agenda Item No. 4:01 Assam Rifles Public School (ARPS) Shillong & 03 Army Public Schools (APS) New Delhi to be designated as Sports School under State Level Khelo India Centres (SLKIC) vertical

The culture of sports and education along with discipline is strongly embedded in Public Schools being run by Assam Rifles and the Indian Army. Proposals have been received in this regard from Assam Rifles and DGMT, Indian Army. In order to promote sports at grassroots level, it is proposed to adopt 01 ARPS, Shillong and 03 APS, New Delhi as Sports School on the lines of 04 Kendriya Vidyalayas (KVs) adopted earlier as SLKIC.

The operational modalities in brief w.r.t. the ARPS and APS are mentioned below:

- i) **Sports Disciplines:** 3-4 disciplines per school to be finalized. DG, SAI may be accorded approval to finalize the disciplines in each school.
- ii) **Talent Identification:** Respective Regional Directors (RD) at SAI RCs to conduct the talent identification at local level for selection of athletes. Common induction norms for Sports Schools will be finalized at later stage.
- iii) **Financial Norms:** The financial norms for ARPS & APS may be finalized post detailed discussions with DG, Assam Rifles for ARPS and with DGMT for 03 APS.

Approval of DPAC is sought for designating 01 Assam Rifles Public School, Shillong and 03 Army Public Schools located in New Delhi as Sports Schools under SLKIC vertical of Khelo India scheme
