 - 3. Air Travel: They will be entitled to air travel as per their entitlement, including airport tax, visa fee, if any, and overseas medical insurance, will be borne by Sports Authority of India.
 - **4.** Accommodation: Suitable accommodation, as per relevant rules, will be arranged by SAI. The same will be intimated separately.
 - 5. Medical Allowance: They will be entitled to medical facility as admissible under the orders issued from time to time. The expenditure will be debited to the source from which the pay is drawn and reimbursed to them.
