- 1. Age Criteria Under-18 (Born on or after 01-01-2008).
- 2. The participating teams are to confirm their participation by filling the confirmation form attached herewith within the given timeline and submitting to mail id: saincoebpl@gmail.com and cc: aman.buss@gmail.com.
- 3. It is mandatory for each team to have two playing kits, uniform in different colours.
- 4. It is obligatory for a female coach/official to accompany the girls teams.
- 5. The athletes must carry proof of date of birth.
- 6. Boarding and Lodging will be provided to all SAI STC athletes as per their entitlement.
- 7. Boarding and Lodging facilities to KIAAs/KICs teams shall be provided on a payment basis inside the campus as per the following financial norms:

- 8. The athletes of KIAA/KIC/KISCE would have to make their own arrangements in the case of non-availability of accommodation in the campus.
- 9. The travel expenses shall be borne by the respective Centres/Academies/STCs.
- 10. The selection of the SAI team for foreign exposure for FY 2025-26 shall also be based on the performance of the athletes in the competition.
