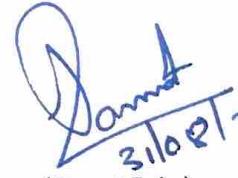
Subject: Repatriation of Shri Abhishek Singh Chauhan, Director (On Deputation)
