#### **Buyer Added Bid Specific Additional Terms and Conditions**

- 1. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

- 3. Buyer Added text based ATC clauses
  - 1. Only bidders within 15 kms. from SAI Head Office are eligible to participate in this tender. Relevant documentary evidence/complete address proof (mention the distance from SAI H.O.. JLN Stadium, New Delhi), shall be submitted with the bid.
  - 2. The vehicle to be provided under this contract shall have the year of manufacturing as 2023 or late
  - 3. All other terms & conditions shall remain unchanged.
