The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
2. Buyer Added text based ATC clauses
 1. Delivery is to be made at various (Nation Centers of Excellence) NCOEs/SAI Centers which are situated PAN India i.e, all states and UTs.
 2. The exact Consignee details and address will be mentioned in supply orders issued by respective NCOEs /SAI Centers.
 3. Submission of Price Bid as a part of Technical bid will lead to rejection of bid

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
