Subject: Engagement of Consultant for Finalization of Recruitment Rule of Sports Authority of India in connection with implementation of Cadre Restructuring for a period of 4 months on full time basis – reg.

Sports Authority of India (SAI) is in the process of revising the Recruitment Rules as part of implementing Cadre Restructuring. A discussion was held under the chairmanship of DG, SAI to engage one consultant to work on full time for Finalization of Recruitment Rule for implementation of Cadre Restructuring in Sports Authority of India an Autonomous Body under the Ministry of Youth Affairs & Sports, New Delhi.

2. Willing and eligible consultants may send their bio-data as per Annexure attached (Overleaf) to the Deputy Director (Pers.), Sports Authority of India, Jawaharlal Nehru Stadium, Lodhi Road, New Delhi. The eligibility, terms and conditions and remuneration are as follows:

Eligibility:

- i. Must acquainted & have dealt with work related to preparation of the Recruitment Rules/ Related matters and Cadre restructuring implementation.
- ii. Should be well aware of various rules/regulations of DoPT & capable to handle administrative issues related to framing of Recruitment Rules with an exclusive experience in the field under reference minimum 7 years.
- iii. Should have worked for framing & completion of RRs for at least two Government organizations/ PSUs/Autonomous Bodies/Statutory Bodies within last 7 years

3.0. Deliverables:

- > Preparation of Recruitment Rules for various cadres of Sports Authority of India as per DoPT/ established norms of Government of India.
- Ensuring the implementation of RR in a smooth manner, resolving issues pertaining to existing employees.

4.0 Terms And Conditions:

- i. The appointment of the consultant for the above related arrangement shall be for a period of 4 months.
- ii. The Consultant should maintain absolute confidentiality and secrecy of the information handled by him/her during the period.
- The consultant shall have to perform duties/services as assigned to him/her by his/her controlling officer with all necessary skills, diligence, efficiency and economy.
- iv. The person engaged on contract basis shall not be entitled to any other benefit.

- v. The consultant will have to attend the office on regular basis.
- vi. No extra compensation will be paid apart from consolidated consultancy fee admissible even if a person attends office on holidays and work beyond normal office hours.
- vii. 'No work no pay' will be applicable during the period of contract.
- viii. The Consultant shall not be entitled to any TA/DA for joining the appointment.
- ix. Engagement may be terminated at any time by the competent authority without assigning any reason and without any notice.
- Recruitment is only for Sports Authority of India, Jawaharlal Nehru Stadium, Lodhi Road, New Delhi-110003.
- xi. Decision of selection committee will be final and binding.

5.0 Consultancy Fee:

The consolidated consultancy fee to be paid maximum upto Rs. 60,000/- per month.

The maximum consultancy fee per month will be decided by Interview Board at the time of Interview. The consolidated consultancy fee will be inclusive of all applicable taxes and no other facility or allowance will be allowed
