- i. <u>Essential qualification</u>: Bachelor Degree in Sports science (or equivalent) from a recognized university.
- ii. <u>Desirable qualification</u>: Master's Degree / Post Graduation diploma in Sports or Exercise science / Human Physiology or Medical Physiology or Exercise Physiology/ Physiotherapy or Sports Physiotherapy /Food and Nutrition or Clinical Nutrition and Dietetics or Sports Nutrition / Biomechanics or Sports Biomechanics/ Kinesiology/ Strength and Conditioning/ High performance Sports/ Sports management/ Post Graduation diploma in Sports Medicine from a recognized university.
- iii. <u>Essential experience:</u> Minimum of 1 year in Sports or Exercise science / Physiology / Physiotherapy /Nutrition or Home Science / Biomechanics / Kinesiology/ Strength and Conditioning/ High performance Sports/ Sports Medicine. - 4. Candidates will be called for the interview on the criteria as mentioned above. Hence, fulfilment of eligibility criteria does not entail that candidate will be considered for the interview.
- 5. The Candidates should note that their candidature at all the stages will be purely provisional, subject to satisfying the prescribed eligibility conditions. 2. TERMS AND CONDITIONS:

2.1 Tenure: The contractual engagement will be initially for a period of two years which could be extended by one year at a time up to a maximum tenure of five years i.e., 2+1+1+1 years. The contract can be terminated by giving a 30 days' Notice period by either party, i.e. SAI or the employee. In cases of extreme impropriety by the employee, the contract will be terminated immediately without prior notice.

** The initial remuneration for the present recruitment shall be fixed as Rs. 60,000/- for Lead (Sport Science). The employee shall be eligible for an annual increment of upto 7% based on the recommendation of reporting officer and reviewing committee. However, the maximum salary after increments can reach upto Rs. 80,000/- for Lead (Sports Science) post which there will be no further increments.

Candidates should note that only the Date of Birth as recorded in the Matriculation/ Secondary Examination Certificate/ Marksheet will be accepted. The maximum age limit will be calculated as on the last date of applications of this notification.

2.3 Tax Deduction at Source: The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the SAI will issue TDS /Service Tax Certificates, as applicable.

2.4 Other Allowances: No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance /Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.

2.5 Extension: Performance of the selected candidates would be continuously reviewed, and their extension will be considered on the basis of periodic review / requirement. Remuneration 7% increment will also depend on the periodic performance review after completion of 01 year of service in SAI, subject to satisfactory performance and recommendation of Reporting Officer and reviewing committee.

2.6 Leave: The Individual Consultants shall be entitled to leave at the rate of 2.5 days of each completed month with no accumulation of leave beyond a calendar year on pro-rata basis. Further, the absence up to one month may be considered without remuneration. However, in Exceptional cases for professional development, training etc. this condition may be relaxed by DG, SAI. Apart from this the women Consultant may be eligible for maternity leave as per the Maternity Benefit (Amendment) Act, 2017 issued by Ministry of Labour and Employment vide no S-36012/03/2015-SS-I dated 12th April 2017.
