SUB: ADDENDUM REGARDING INCLUSION OF RESERVATION FOR PERSONS WITH BENCHMARK DISABILITIES (PwBD) IN THE RECRUITMENT TO THE POST OF PERFORMANCE ANALYST – REG.

SAI is an autonomous organization under the Ministry of Youth Affairs & Sports (MYAS) registered under the Societies Registration Act, 1860, invites application from eligible candidates for appointment to the post of Performance Analyst on Regular basis in 07 disciplines.

2. With reference to the Advertisement issued for regular recruitment to the post of Performance Analyst in the Sports Authority of India (SAI), it is hereby informed that, in accordance with the **Rights of Persons with Disabilities Act, 2016** and the **Notification dated 06.03.2026 issued by the Department of Sports, Ministry of Youth Affairs & Sports, horizontal reservation for Persons with Benchmark Disabilities (PwBD)** shall be applicable for the said recruitment.
3. The categories of benchmark disabilities identified as suitable for the various disciplines of Performance Analyst [Kindly refer (**Appendix -I**)] shall be applicable as notified by the Department of Sports, Ministry of Youth Affairs & Sports.
4. **Age Relaxation:**

Further, Age Relaxation for PwBD candidates shall be applicable as per extant Government of India/DoPT guidelines, i.e., as given below:

Up to a maximum of 10 years in the case of candidates belonging to Persons with Benchmark Disabilities (PwBD) categories viz.

- (i) blindness and low vision;
- (ii) deaf and hard of hearing;
- (iii) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- (iv) autism, intellectual disability, specific learning disability and mental illness;
- (v) multiple disabilities from amongst person under clauses (i) to (iv) including deaf-blindness.

5. **Application Fee:**

The application fee for PwBD candidates shall be only **Rs. 1500/- (Rupees One Thousand Five Hundred only)**.

6. The Persons with Benchmark Disabilities in the categories of blindness, locomotor disability (both arms affected – BA) and cerebral palsy will be provided the facility of scribe, if desired by the person. In case of other category of Persons with Benchmark Disabilities as defined under section 2(r) of the RPWD Act, 2016, the facility of scribe will be allowed to such candidates on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his/her behalf, from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government Health Care institution as per proforma provided in the **Annexure- I**.
7. The Persons with Benchmark Disabilities in the category of blindness, locomotor disability (both arms affected – BA) and cerebral palsy will be allowed **Compensatory Time of twenty minutes per hour of the examination**. In case of other categories of Persons with Benchmark Disabilities, this facility will be provided on production of a certificate to the effect that the person concerned has physical limitation to write from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government Health Care institution as per proforma at **Annexure- I**.
8. The candidates have discretion of opting for his/her own scribe. The details of scribe will be sought at the time of filling up the application form online as per the **Annexure- II** (for Candidates having 40% disability or more) and as per the **Annexure- III** (for Candidates having less than 40% disability and having difficulty in writing). Suitable provisions in Application Form have been made.

Note: A candidate of Persons with Benchmark Disability will be considered to be eligible for appointment only if the candidate (after such physical examination as the Government or the Appointing Authority, as the case may be, may prescribe) is found to satisfy the requirements of physical and medical standards for the concerned Services/Posts to be allocated to candidates of Persons with Benchmark Disability by the Government.

9. Furthermore, the Undertaking for bringing own scribe provided at Annexure -II or III has to be duly filled by the candidate and has to bring and submit the same at the centre.
10. All other terms and conditions of the advertisement shall remain unchanged.
