- 2. The Committee will examine the complaints referred to it on the subject and submit its findings/report to the Competent Authority in a time bound manner in the following prescribed procedures:-
  - (a) The Internal Complaints Committee will act as the Inquiry Authority appointed by the Disciplinary Authority in cases of sexual harassment by virtue of proviso to Rule 14(2) of CCS (CCA) Rules read with Rule 3-C of the CCS (Conduct) Rules, 1964. The report of the Committee will thus be deemed as an inquiry report. The Disciplinary Authority may act on the report in accordance with the rules.

- (b) The Committee should function strictly according to the guidelines of Ld. Supreme Court in the Vishaka Judgement and must make an annual report to the Competent Authority concerned of the complaints and action taken thereon.
- (c) In addition to complaints related to sexual harassment, the Committee will make itself visible by adopting various preventive mechanisms, creating awareness by organizing training workshops and also deal with matters of general interest to the Committee.
- (d) The Committee will function within its jurisdiction.
- 3. This may be given wide publicity amongst the Officers/staff of SAI HQ (including 5 Stadia located in Delhi).
