NOTICE – INVITING APPLICATIONS FOR ENGAGEMENT OF CONSULTANTS IN  
SAI ON CONTRACT BASIS

Sports Authority of India (SAI), invites application for engagement of services of retired persons as Consultant on contract basis initially for a period of one year extendable up to 3 years on annual periodical review basis.

## 2.0 About SAI

2.1 SAI is an autonomous organization under the Ministry of Youth Affairs & Sports (MYAS) registered under the Societies Registration Act, 1860, with the mandate of development and promotion of Sports in the country. SAI's main object today is to achieve excellence in sports and train & prepare sports persons to participate in International competitions. It has international standard sports infrastructure spread across country along with trained coaches to achieve its objective. The Authority is substantially funded by the Government of India.

## 3.0 Eligibility Condition

The officers who retired from the Central/State Govt., Autonomous Organization/Statutory Bodies under Government of India/State Government can apply for appointment as a Consultant, having sufficient (7-8 Years) experience/specialization in any of the following fields:-

- i) Human Resource
- ii) Administration/Personal matters viz. Establishment, Pension, Revision of Pay, Seniority and Promotion etc. (Preferably from DOPT)
- iii) Vigilance/Disciplinary/Court cases etc.
- iv) Procurement of Equipment etc. including through GEM.
- v) Matter related to Audit etc.
- vi) Maintenance of Infrastructure
- vii) Preparation of Budget and release of grant etc.
- viii) Preparation of Tender/e-tender/contract/agreement related to various works.

## 4.0 Maximum Age

Not exceeding 65 years.

## 5.0 Selection Process

The candidate fulfilling the eligibility criteria will be called for interview and the selection will be made on the basis of the recommendations of duly appointed Selection/ Interview Committee.

## 6.0 Remuneration

Selected candidates will be paid consolidated remuneration to be worked out on the basis of last pay drawn minus pension + DA applicable as on date rounded off to the nearest 100 Rupees.

## 7.0 How to Apply

Candidates satisfying all the conditions of eligibility, shall submit their application completed in all respect in the prescribed format given in the Annexure which shall be either handwritten in bold capitals or typewritten on A-4 size paper only. The copy of the certificate in proof of age, qualification, experience, Last Pay drawn and drawal of pension etc. must be enclosed along with application form.
