Institutional/ Regional Heads,

Sub: Provision of Sports Kit to the Non-Residential and Residential trainees under various sports promotional schemes of SAI

The Competent Authority has decided to allow the selected trainees of various sports promotional schemes of SAI (except ABSC Scheme) to purchase their discipline specific sports kit from the market on their own. For this purpose, the sports kit amount earmarked under the each scheme, as per the approved scheme norms, shall be transferred to the individual bank account of the scheme trainees by the respective Regional offices/ Incharge Centres. The amount will be transferred only, where the sports kit has not yet been procured and distributed by the Regional Offices. In order to regulate the present mode of procurement, the following guidelines shall be adhered to by the Regional offices:

- i) The sports kit amount earmarked as per the approved scheme norms as per the annexure attached, shall only be transferred to the individual bark account of the trainees through NEFT by the concerned Regional Offic J/ Centre Incharge.
- The amount transferred to the bank account of the trainee shall be treated as an advance and its adjustment will be carried out by the respective Regional Heads/ Centre Incharge within a specified time limit on obtaining the original purchase voucher from the respective trainees. The amount will be adjusted and accounted under the appropriate expenditure head after proper stock entries in the stock registers.
- The trainees of the particular sports discipline in the centre shall, however, ensure that the colour uniformity is maintained at least in the sports wear like T Shirts, Shorts and Track Suits for identification of the players of that discipline for proper training.
- iv) The trainees shall also ensure that the kit amount is utilized for the purposes it is earmarked, however, they may buy a particular item of higher value by meeting the extra cost on their own, but not in any case less than the amount paid by SAI for the purchase of the sports kit.

The process of transfer of amount, we rever the sports kit has not yet been provided shall be completed by the Regional Offices within a fortnight and the trainees must purchase the kit within 15 days from the date amount stands transferred to their bank account. The discipline concerned coaches shall ensure that the trainees submit their purchase vouchers with the concerned Regional Centre/ Centre Incharge immediately after making the purchase for settlement of the amount
