#### 2. BACKGROUND

- i) An MOU was signed between National Sports Development Funds (NSDF), Sports Authority of India (SAI), NTPC Ltd and Archery Association of India to support the sport of 'Archery' in the country by infusing funds at the grassroots level for five (5) years under the project called as "NTPC-Dhanurvidya Project" under various components such as training, coaching sports science, equipment, FOP, competition exposure, identification and support schools and academies etc.
- The journey of an Archer begins with school or academy and progresses through the zonal, district, and national levels onward to representing India at the international levels. Identifying and nurturing hidden and natural talents at an elementary level and providing the necessary facilities is one of the key ways to improve their performance and take them to the next level. Despite having good intentions regarding sports, some schools/academies do not have enough budget, equipment, infrastructure, and technical support.

#### 3. AIMS & OBJECTIVES

- i) The objective is to produce a pipeline of talented Archers and to prepare them giving special focus on the upcoming 2028, 2032 & 2036 Olympic Games that would help India emerge as a dominant force in World Archery. This will also help broaden the pool of sportspersons in the country.
- ii) To identify sporting talent who possess inborn qualities.
- iii) To nurture the sporting potential/talent at the school and academy level to make them excel at National and International competitions by providing the best facilities and professionally structured pathways for participation in International competitions.
- iv) This scheme aims to adopt potential schools/academies by extending financial support in terms of field & playing equipment, ground development, honorarium to PET/Coach/Support Staff, and strengthening their skills and techniques through holding education programs.

#### 4. Support to be extended under the scheme

4.1. 3-Tier grading scale (Tier-1, Tier-2 & Tier-3) would be adopted for the selection of schools/ academies under the scheme as per details mentioned below -

- 4.3 The components of financial assistance will be as follows -
- 4.3.1. **Provision of Funds for Equipment** The below-mentioned standard equipment to each of the selected schools/academies would be provided
  - a) **Field Equipment** 4 sets of Targets including Target Buttresses, Target Stands, Target Faces, and Target Face Pins for all schools/academies irrespective of Tier-1, Tier-2 & Tier-3.
  - b) Playing Equipment
    - i. 4 complete sets of playing beginners' equipment including Bow (handle + Limb + String), Stabilizer system, Arrows, Quiver, Arm Guard, Finger Tab, Chest Guard etc. for Tier-1, Tier-2 and Tier-3 schools/academies.
    - ii. In addition, high-standard equipment for Tier-2 & Tier-3 schools/academies based on their performance.

- 4.3.2. **Provision of Funds for Ground Development** One-time financial assistance will be extended to each selected school/academy annually to develop/upgrade and maintain the existing archery range and allied infrastructure. Technical support and guidance to the schools in terms of the layout for setting up the archery range will also be provided.
- 4.3.3. **Honorarium to PET/Coach/Support Staff** Financial Assistance on account of honorarium to the PET/Coach/Support Staff of the school/academy will be given.
- 4.3.4 **Talent Scouting Event** The budget allocation for arranging a Talent Scouting Contest annually in collaboration with the State/District Archery Association has also been made under the project.
- 4.3.5 **Branding -** One-time branding cost for publicity material will also be extended.
- 4.3.6 **Coaching & Training -** The designated PET/Coach(es)/Support Staff will be trained through e-learning at no additional cost.

#### 5. Accreditation/Extension Methodology

- 5.1 Schools/Academies will be ranked based on points acquired by Archers training in the said schools/academies at various levels of competitions. The 'Points Matrix Table' for the selection/extension of schools/academies is attached, however, the detailed policy on inclusion/exclusion will be framed and shared with the selected schools/academies separately.
- 5.2 Upgrading/downgrading of Schools/Academies will be reviewed annually based on the most recent performance of Schools/Academies in various events.
- 5.3 If a student(s) of a school is training in an academy then preference of funding will be given to the academy. In such cases, schools will be considered only if the archer(s) is undergoing training in the school.
- 5.4 If the points of two or more schools/academies are the same, the schools/academies located from North-East, J & K, Ladakh, Tribal Areas, and Rural Areas will be given preference in the given order.
- 5.5 The implementation of the scheme and the performance of schools/academies would be continuously monitored and reviewed. Continuation/extension will be considered based on outcomes.
- 5.6 The designed committee of the AAI reserves the right to recommend to the Steering Committee for inclusion or withdrawal of the support at any time without any prior notice in case of any unsatisfactory report performance or any other gross misconduct or infringement of rules.
- 5.7 The school will be willing to give due recognition for the support by way of putting up signage and branding material in the school and through the electronic media, print media and school website.

  - Central/ State Government/ PSUs/Autonomous bodies/ Sports Academies, National Sports Federations, sports training centres, sports stadia recognized by Government;

- b) As part of the process, AAI will form a panel of experts to assess various facilities, systems & processes of each applying academy. They will oversee the pre-accreditation selection of the academies.
- c) The School/Academy shall not be allowed to assign and/or outsource its responsibilities in any circumstances whatsoever.
- d) The School/Academy shall be solely responsible for the safety and security of players at all times and shall keep AAI indemnified in this regard.

#### 7. PRE-QUALIFICATION CRITERIA

Each School/Academy should meet the following basic criteria as a prerequisite to be considered in the application process of this EOI:

#### i. **Legal Entity:**

- a) The Applicant must be validly incorporated under the relevant provisions/ Acts in India. The Applicant has to be necessarily registered and existing in India. Consortium/ Joint Venture is also allowed.
- b) The Academy must be a well-established Archery academy in the field for the last 2 (two) years.

#### ii. Technical Ability:

- a) The School/Academy should have a playing ground space of a minimum of 80 mtrs long and 25 Mtrs wide to set up the Archery range.
- b) There should be a PET teacher or a qualified coach in the school/academy who will look after all assignments under the project.

#### iii. Willingness:

The school/academy will be willing to give due recognition for the support by way of putting up signage and branding material in the school/academy, through the electronic & print media and school/academy website at no cost to the AAI.

#### 8. CONFLICT OF INTEREST

- i. Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the Applicant to inform AAI, detailing the conflict in writing as an attachment to this application.
