Subject: Blacklisting Order of M/s Mayor Sports Private Limited, Noida.

Dear Sir/Madam,

The undersigned is hereby convey the approval of the Competent Authority regarding the blacklisting of **M/s Mayor Sports Private Limited**, A-42, 2nd Floor, Sector-63, Noida-201301 (Contact No: 9810174325, 9918670715, +91-120-4981744, Email: info@mayorsports.com, tenders@mayorsports.com, nitin@mayorsports.com), following their failure to fulfill contractual obligations under the **Work Order No. 08-07/2/2023-Admin-MDCNS/2025 dated 20.03.2025** for the supply of **120 Kookaburra Hockey Balls** for NCOE, Major Dhyan Chand National Stadium, New Delhi.

This action has been taken in accordance with the **Guidelines on Debarment of Firms from Bidding** issued by the **Department of Expenditure, Ministry of Finance** (OM No. F.1/20/2018-PPD dated 02.11.2021), after ensuring due process and granting multiple opportunities for the firm to respond.

The implications of blacklisting of said firm is mentioned as below:


1. **M/s Mayor Sports Private Limited** will be barred from participating in any current or future procurement activities under the **Sports Authority of India** for a period of **One (1) year**, effective from the date of issuance of blacklisting order.
2. **M/s Mayor Sports Private Limited**, Noida, shall not be permitted to participate under any new name, entity, or joint venture in procurement under Sports Authority of India the period of blacklisting.
3. All procurement departments under the Sports Authority of India are directed to refrain from engaging with M/s Mayor Sports Private Limited for any procurement activities during this period.

Therefore, all the regional centers, NCOEs and associated procurement units of SAI are requested to:

- **Refrain from engaging** with M/s Mayor Sports Pvt. Ltd. for any ongoing or upcoming procurement;
- **Remove the firm from any active bidder or vendor lists;**
- **Ensure compliance** with this directive in all tendering platforms and offline processes.

Furthermore, it is requested to **Information Technology (IT) Division, SAI-HO** to publish the details of the said blacklisting on the official Sports Authority of India website to ensure transparency.

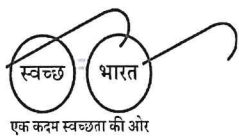

ORDER

This has its reference from the SAI-MDCNS Work Order No. 08-07/2/2023-Admin-MDCNS/2025 dated 20.03.2025 for **supply of 120 Kookaburra Hockey Balls for NCOE, MDC National Stadium, New Delhi**, awarded to **M/s Mayor Sports Private Limited, Noida**, for providing the Kookaburra Hockey Balls at **Major Dhyan Chand National Stadium**, Sports Authority of India, at the cost of ₹4,09,800/- including taxes.

WHEREAS, as per the terms and conditions in the quotation submitted for the said requirement by M/s Mayor Sports Private Limited, Noida, was required to ensure timely supply of 120 quantities of Kookaburra Hockey Balls at MDCNS under this agreement. However, it was brought to the attention of the undersigned that the said items in the ordered quantity have not been supplied at MDC National Stadium, New Delhi.

WHEREAS, the failure to supply of 120 quantities of Kookaburra Hockey Balls at MDCNS on time has caused undue hardship to the affected personnel/hockey athletes and constitutes a breach of the contractual obligations as agreed upon by your firm vide Quotation No. MSPL/002/3-25 dated 10.03.2025. Despite repeated reminders and formal communication from the office of the Administrator, Major Dhyan Chand National Stadium (MDCNS), there has been no satisfactory resolution of this issue. The office of the Administrator, MDCNS, has made several email reminders, telephonic follow-ups urging M/s Mayor Sports Private Limited, Noida, to immediately supply the required 120 quantities of Kookaburra Hockey Balls. However, these efforts have not yielded the desired outcome.

WHEREAS, on 20.06.2025, the Administrator, MDCNS, -issued a formal reminder notice through email to M/s Mayor Sports Private Limited, Noida, requiring them to submit a valid justification for the delay in supply of the requisite quantities of Kookaburra Hockey Balls at MDCNS. It was also mentioned in the final reminder notice that failing to provide proper justification, the work order shall be compelled to be cancelled without further notice and appropriate actions may be initiated against the firm.

WHEREAS, on 14.07.2025, with the approval of the Competent Authority, the issued work order to M/s Mayor Sports Private Limited, Noida, for supply of 120 quantities of Kookaburra Hockey Balls for NCOE, MDC National Stadium, New Delhi, was cancelled with immediate effect, and the same was intimated to the firm through email.

WHEREAS, M/s Mayor Sports Private Limited, Noida, has been found to have violated the terms and conditions as agreed and produced vide submitted quotation, wherein it was

mentioned that the material would be supplied within 15 days of the receiving the work order, which constitutes a breach of the contract and non-compliance with the statutory obligations under the relevant provisions of procurement under the Sports Authority of India.

WHEREAS, a Show Cause Notice dated 25.07.2025 was duly issued to M/s Mayor Sports Private Limited, Noida, providing them with an opportunity to explain the reason for their non-compliance in supplying the requisite quantities of Kookaburra Hockey Balls at MDCNS and violation of contractual obligations. However, despite this notice and sufficient time being given, the explanation provided by the company has been deemed unsatisfactory and insufficient to justify their non-compliance.

WHEREAS, M/s Mayor Sports Private Limited, Noida, –have led to a breach of the contractual terms under procurement and also violated the terms and conditions as agreed and produced vide submitted quotation, wherein it was mentioned that material would be supplied within 15 days of the receiving the work order.

NOW, THEREFORE, in exercise of the clause 5(c) under Debarment by a Single Ministry/ Department of the “Guidelines on Debarment of firms from Bidding” annexed to the Office Memorandum No.F.1/20/2018-PPD dated 2nd November 2021, issued by the Department of Expenditure, Ministry of Finance, Procurement Policy Division, which states that “*A bidder can also be debarred for any actions or omissions by the bidder other than violation of code of integrity, which in the opinion of the Ministry/ Department, warrants debarment, for the reasons like supply of sub-standard material, non-supply of material, abandonment of works, sub-standard quality of works, failure to abide "Bid Securing Declaration" etc*”. and relevant procurement regulations, the undersigned, after due consideration of the facts, circumstances, and violation of contractual and legal obligations, hereby orders as follows:

M/s Mayor Sports Private Limited, A-42, 2nd Floor, Sector-63, Noida-201301 (India) is hereby blacklisted from participating in any current and future procurement activities under Sports Authority of India for a period of One (1) year, effective from the date of issuance of this order. This action is in accordance with the relevant Guidelines on Debarment of firms from Bidding issued by the Department of Expenditure, Ministry of Finance, Procurement Policy Division, and Procurement Rules for breach of contract and non-performance.

M/s Mayor Sports Private Limited, Noida, shall not be permitted to participate under any new name, entity, or joint venture in procurement under Sports Authority of India the period of blacklisting.

All procurement departments and entities under the jurisdiction of the Sports Authority of India are hereby directed to refrain from engaging with M/s Mayor Sports Private Limited, Noida, for any procurement activities or any other Government procurement process during the blacklisting period.


All ongoing contracts with M/s Mayor Sports Private Limited, Noida, shall be subject to review by the respective procuring departments. Appropriate actions may be taken, including but not limited to the termination or cancellation of ongoing contracts for non-performance,

delay, and violation of the terms of service, subject to the Contract Act, 1872, and the General Financial Rules.

Further, a copy of this blacklisting order will be forwarded to all procurement departments and entities under the jurisdiction of the Sports Authority of India for their records. M/s Mayor Sports Private Limited, Noida, will be marked as ineligible for participation in any future procurement activities under Sports Authority of India during the blacklisting period, and shall also be published on the official website of Sports Authority of India to ensure transparency.

M/s Mayor Sports Private Limited, Noida, has the right to appeal this blacklisting order to the Competent Authority as per the formal procedures and guidelines of Sports Authority of India. The appeal must be submitted in writing within 30 days from the date of issuance of this order. The Competent Authority shall review the appeal in accordance with the formal appeal procedure and provide a final decision.
