**TERMS AND CONDITIONS FOR SUPPLY OF PORTABLE COMBINATION THERAPY UNIT
(INTERFERENTIAL THERAPY + ULTRA SOUND MACHINE + TENS)**

1. Sealed Tenders are invited by Sports Authority of India from manufacturers/Suppliers/dealers for supply of one Portable Combination Therapy Unit (Interferential Therapy + Ultra Sound Machine + Tens). The equipment to be supplied to Netaji Subhash Regional Centre, Sarojini Nagar, Kanpur Road, Lucknow.
2. The word "Tender for supply of Portable Combination Therapy Unit (Interferential Therapy + Ultra Sound Machine + Tens)" should be super scribed on the top left corner of the envelope bearing the name & address of the tenderer. The sealed tender should accompany with the following :-
 - a) Tender document completed in all respect duly signed by the tenderer, Tender cost of Rs. 500/- (rupees five hundred only) separately in case downloaded, along with Earnest money amounting to Rs 11,000/- in the form of Demand Draft drawn in favour of Regional Director, Sports Authority of India, Netaji Subhash Regional Centre, payable at Lucknow, should be submitted in **Envelope 'A'**. In case, the amount of EMD and tender cost is deposited by cheque, the tender will be rejected.
 - b) The rates quoted as per performa at **Annexure - II** to be submitted in **Envelope 'B'**.
3. The tender shall be submitted in one envelope (containing 02 separately sealed envelopes `A&B') as above, in the office of the Regional Director SAI Netaji Subhash Regional Centre, Sarojini Nagar, Kanpur Road, Lucknow.
4. The tenders received without the above will summarily be rejected.
5. If even after approval information / facts submitted by the tenderer are found misleading / incorrect etc., SAI reserves the right to reject the equipment for the current / future rate contract or may impose penalties as deemed fit. Non compliance of any of the terms & conditions of the tender will also warrant above penalties.
6. Rates quoted should be inclusive of taxes/vat and freight charges. F.O.R. Netaji Subhash Regional Centre, Sarojini Nagar, Kanpur Road, Lucknow.
7. EMD of the unsuccessful bidders will be refunded after finalization of the Tender.
8. Interest free performance security deposit equivalent to 10% of the total estimated value of the supply order will be deposited by the successful bidder, with in seven days of award of supply order. Security Money will be refunded after expiry of warranty period.

9. Technical specification of the Portable Combination Therapy Unit (Interferential Therapy + Ultra Sound Machine + Tens) should be as given below :-

a.	Should have all low & medium frequency current forms including Galvanic, Biphasic, Interferential, Russian, High Voltage, Micro Currents etc.
b.	2 Independent channels for Synchronized, Alternate, Separate treatments for agonist/antagonist treatment or different site treatment.
c.	Should display the effect of the current form used on screen e.g. efficacy in analgesia, strengthening, relaxation etc.
d.	Should have inbuilt special programmes for Sports Rehab, Paralysis etc.
e.	Should have More than 100 specific programs.
f.	Should have multi frequency ultrasonic therapy unit.
g.	Should have the Possibility of setting the desired depth of penetration with using both the frequencies.
h.	Transducer head should be water resistant with audio & visual contact indicator.
i.	Should have disease wise program and manual program.
j.	Should have Colour touch screen monitor for better control and ease of operation.
k.	On screen help for various common diseases should be available.
l.	Expandable SD Memory.

10. Supply to be made within 30 days from the date of Supply Order.

11. Subject to the provision of Force Majeure, if the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, the purchaser shall, without prejudice to other rights and remedies available to the purchaser under the contract, deduct from the contract price /security deposit, as liquidated damages, a sum equivalent to 0.5 % per week of delay or part thereof on delayed supply of goods and / or services until actual delivery or performance subject to a maximum of 10% of the contract price.

12. The Regional Director will have the right to reject any or all the bids without assigning any reason.

13. The equipment supplied if found not as per specification of tendered items, are liable to be rejected.

14. The Regional Director, SAI Netaji Subhas Regional Centre, Lucknow will be legally competent to cancel the supply order and also to take any other action against the supplier including imposing of any penalty on the supplier during pendency and till the final execution of the contract of the supply, in case the supplier is ever found to have committed any fraud against SAI Netaji Subhas Regional Centre, Lucknow in supplying the material or indulge in any other malpractices thereof causing any financial losses during contract period.

15. In case any dispute with regard to this tender, the decision of the Regional Director, SAI Netaji Subhas Regional Centre, Lucknow will be final and binding.

16. In case of litigation, the courts at Lucknow only will have jurisdiction for deciding case according to Indian law in force.

17. The technical bids will be opened first and the financial bid will be opened only of those bidders whose Technical bid shall be accepted by the competent authority.

18. It may be noted that this is just an enquiry and does not amount to any commitment on the part of Sports Authority of India to order any products offered. The decision of Sports Authority of India in this regard would be final and be entirely, at its discretion.

19. Regional Director, SAI Regional Centre Lucknow reserves the right to reject tender without assigning any reasons. If the equipment is found to be defective in material, size, quality or any other defect of specification or manufacturing defect, then the penalty of 10% of total price of the equipment will be deducted from the security deposit and in addition to, that SAI is not liable to make payment for the Physiotherapy equipment supplied.

20. The supplier is required to apply to the purchaser for extension of delivery period and obtain the same before despatch. In case the supplier despatches the Physiotherapy Equipment without obtaining an extension, it would be doing so at its own risk and no claim for payment for such supply and / or any other expense related to such supply shall lie against the purchaser.

21. The purchaser, without prejudice to any other contractual rights and remedies available to it (the purchaser), may, by written notice of default sent to the supplier, terminate the contract in whole or in part, if the supplier fails to deliver any or all of the goods or fails to perform any other contractual obligation(s) within the time period specified in the contract, or within any extension thereof granted by the purchaser.

22. The warranty period of the equipment should be for a minimum period of one year.

23. All tenderers will submit a catalogue of Portable Combination Therapy Unit (Physiotherapy Equipment) .

24. Rates should be valid for six months. No escalation in price on any account will be accepted.
