**1. EMD**

EMD can be deposited by D.D. of nationalized or scheduled bank drawn in favour of SAI Public Account payable at Kolkata.

**2. Inspection**

Vehicle / documents will be available for inspection on working days from 05.04.2018 to 24.04.2018 between 10.30 A.M. to 5.00 P.M. Sports Authority of India, Netaji Subhas Eastern Centre, Salt Lake City, Sector-III, Kolkata. No counter conditions or relaxations of conditions mentioned in the tender will be accepted.

**3. Submission of offer/ tender**

**4. Opening of the Bid**

Bid will be opened on 25.04.2018 at 3.30 P.M. Price Bid in respect of only those tenderers shall be valid who have submitted D.D. towards EMD. The bidder or their authorized representative (not more than one) may witness the tender opening at the time of opening of the quotations.

**5. Acceptance**

SAI reserves the right either to accept / reject any offer at its discretion. After offers are opened, sale may be postponed or cancelled or SAI at its discretion can hold a limited auction amongst Tenderers who have offered bids. Highest successful

tenderer will have to deposit 100% of the final bid on the spot before leaving the SAI premises. It is, therefore necessary, all tenderers/Authorised Representatives should be present at the time opening of the price bid at SAI on 25.04.2018 on 3.30 P.M.

**6. Tax / Insurance etc.**

All applicable Taxes except road taxes will be levied by SAI & payable by the bidder over and above the bid price.

**7. Possession**

Sale letter will be issued only in the name & style of tender under which offer is made. Vehicle should be removed from SAI premises within four days from handing over sale letter. In case vehicle is not removed after four days demurrage will be charged at the rate of Rs.200/- per day per vehicle and after 15 days SAI at its discretion may confiscate the amount deposited and dispose the vehicle in the best interest of SAI. No complaint will be entertained in this matter.

It will be responsibility of purchaser to get vehicle transferred in his name, NOC if necessary will be given by SAI. Set of documents for RTO Transfer has to be signed by the Purchaser in presence of Asstt.Director (GAD), SAI before physically removing the vehicle from SAI's premises.
