EMD amount of Rs.1,00,000/- (Rupees one lac only) through crossed Demand Draft drawn in favour of the Regional Director, Sports Authority of India, Bhopal payable at Bhopal along with tender cost Rs.1,000/- (Rupees One thousand only) through Demand Draft drawn in favour of the Regional Director, Sports Authority of India, Bhopal . **(To be submitted in Envelope -A as per Annexure-I)**
