**TERMS AND CONDITIONS FOR SUPPLY OF JUDO, KABADDI, TAEKWONDO  
AND WRESTLING MATS WITH COVER**

1. The words “**Tender for supply of Judo, Kabaddi, Taekwondo and Wrestling Mat with cover**” should be super scribed on the top left corner of the envelope bearing the name & address of the tenderer. The sealed tender should contain the following three **separately sealed envelopes**:-

**Envelope ‘A’:**           **EMD amount of Rs.83,500/-** (Rupees eighty three thousand five hundred only) in the form of Bank Demand Draft in favour of Regional Director, SAI, NSRC, Lucknow payable at Lucknow **be submitted in Envelope ‘A’ as per Annexure-V. Tenders with cheque(s) will be rejected.**

**Envelope ‘B’**           **Tender document**, complete in all respects duly signed by the tenderer, along with the all supporting documents and list of samples of Judo, Kabaddi and Taekwondo Mats having name of tenderer/brand/article no. as per proforma at **Annexure II be submitted in Envelope ‘B’.**

**Envelope ‘C’**           Rates be quoted (**Financial Bid**) as per proforma at **Annexure - III and be submitted in Envelope ‘C’.**

2. The tender shall be kept in one big envelope,(**containing 03 separately sealed envelopes i.e. A, B & C**, as above), and deposited in the tender box placed in the office of SAI, NSRC, Sarojini Nagar, Kanpur Road, Lucknow on or before **12.01.2016** upto **2.30 P.M.**

3. The tenders received without the above will summarily be rejected.

4. The suppliers are required to submit a piece of **sample** of Judo, Kabaddi, Taekwondo and Wrestling Mats with cover to be supplied along with the tender documents.

5. In case of doubt in material, supplied by the firm/tenderer, the expenditure incurred on getting the **material tested** will be borne by the tenderer.

6. If, even after approval, **information/facts** submitted by the tenderer are found **misleading / incorrect** etc., SAI reserves the right to reject the tender for the current / future supply or may impose penalties as deemed fit. Non compliance of any of the terms & conditions of the tender will also warrant above penalties.

7. **Rates** quoted should be inclusive of all applicable **taxes/vat etc.** for complete wrestling mat set & cover.

8. Interest free **security money** equivalent to 10% of the total value of the supply order will be deposited by the successful bidder, with in seven days of award of supply order. The EMD will be refunded after finalization of tender in respect of successful bidder. Security Money will be refunded within 60 days on completion of all contractual obligations, if no complaints are received during the period of warranty.

9. **EMD** of the unsuccessful tenderer will be **refunded** after finalization of Tender.

10. **Technical specification and requirement** of the Judo, Kabaddi, Taekwondo and Wrestling Mats with cover are as per **Annexure IV**.

11. **Material indented for shall be supplied as per specifications** (refer sl. no.10 above), in full quantity within stipulated time and at place indicated in the supply order. In case of non compliance in any of the above or any other complaint, SAI reserves the right to reject the supply or may take any other action as deemed fit including legal action. In case of any other defect etc then the penalty of 10% of total price of the supply order in addition to refund for returned / rejected goods, will become payable to SAI.

12. The SAI, NSRC, Lucknow will have the right to reject any or all the tenders at any stage without assigning any reason.

13. The SAI, NSRC, Lucknow will be legally competent to cancel the supply order and also to take any other action against the supplier including imposing any penalty during or till the final execution of the supply, in case the supplier is ever found to have committed any **fraud against SAI** in supplying the material or indulged in any other malpractices thereof causing any financial losses during contract period.

14. The successful tender will give an self attested declaration (as at **Annexure I**) on Rs 100/- Stamp Paper certifying that the quality and specifications/brand of Judo, Kabaddi, Taekwondo and Wrestling Mats with cover, quoted in the tender are correct and as per specifications approved by respective International / National Federations. In case of any defect, SAI, NSRC, Lucknow may impose penalty as deemed fit and will have the right to make recovery from security or any pending bills or and take any legal action as deemed fit.

15. SAI taking into account, **past performance** of the tenderer, reserves the right to reject any tender.

16. In case, any **dispute** arises in regard to the tender, the decision of the SAI, NSRC, Lucknow will be final and binding.

17. In case of **litigation**, the courts at Lucknow only will have **jurisdiction** for deciding case according to Indian law in force.

18. The **technical bids** will be opened first and **financial bids** of only those bidders shall be opened whose Technical bids are accepted by the competent authority.

19. It must be noted that this is **just an enquiry** and does not amount to any commitment on the part of SAI to order any products offered. The decision of SAI in this regard would be final and be entirely, at its discretion.

20. The supplier shall not **despatch** the ordered material **after expiry** of the delivery period. The supplier shall apply to SAI, NSRC, Lucknow for extension of delivery period and obtain approval before despatch. In case the supplier despatches the goods late, without obtaining an approval for extension, it would be doing so at its own risk and no claim for payment for such supply and / or any other expense related to such supply shall lie against SAI, NSRC, Lucknow.

21. In case of delayed supply damages equivalent to 0.5% of the contract price, per each week of delayed supply until actual delivery subject to a maximum of 10% of the total cost of the ordered equipment.

22. The **warranty period** of the Judo, Kabaddi, Taekwondo and Wrestling Mats with cover should be **for a minimum period of one year**.

23. The bidders are required to declare list of pending court cases/disputes/claims with arbitration court / consumer forum etc. in the court of law and also give any specific decisions/directions given by the Hon'ble court as per **Annexure VI**. In case any information provided is found to be false or incomplete, the bid is liable to be rejected / terminated any time. This declaration to be given on Rs 100/- stamp paper.

24. Supply of Judo, Kabaddi, Taekwondo and Wrestling Mats with cover will be made within 15 days from the date of Supply Order at locations mentioned at **Annexure IV**.

25. The Bidder must be an Authorized supplier / distributor of the manufacturer and in business of supply of said mats. The bidder should furnish documentary proof along with the bid in support of above.

26. The requirement of mats mentioned at Annexure IV is tentative requirement and if requirement of mats further arises within one year, the repeat order of required mats may be again placed.
