GENERAL TERMS & CONDITIONS & DUTIES OF STAFF

1. The words “tender form for the **OPERATION AND COMPREHENSIVE MAINTENANCE OF FLOOD LIGHT IN SYNTHETIC HOCKEY FIELD & STREET LIGHT AND NON COMPREHENSIVE MAINTENANCE OF ALL ELECTRICAL INSTALLATION AT SAI CRC BHOPAL FOR THE YEAR 2015-16 for one year** “should be subscribed on the top left corner of envelope bearing the name and address of the tenderer. The tender shall be submitted in three separate envelopes addressed to “ Regional Director, Sports Authority of India, Sports Complex, Gram Gora, Bishenkheri, Bhopal (MP) as under :
 - a) **Envelope ‘A’ : Earnest Money Rs.20,000 (Rupees twenty thousand only)** by demand draft in favour of REGIONAL DIRECTOR, SAI, BHOPAL (MP) from any Nationalized Bank (**Annexure-II**).
 - b) **Envelope ‘B’** should contain all the tender documents duly signed by the tendered on each page and all other documents to be submitted along with the tender as per details given in **Annexure-III** along with information pertaining to the present line of business.

3. The successful tendered will have to submit a list of all the employees along with address for security reasons at the time of awarding of contract.

5. That in order to keep up to date management the successful tendered shall be responsible for using such equipments and materials as may be necessary in consultation with Regional Director, SAI CRC Bhopal.
6. **(A) Comprehensive Maintenance of Flood Light & Street Lights:-**

Following scope of work will be provided by the contractor for operation and maintenance of flood light in Hockey synthetic field and street light:

 - i. Maintenance work of electrical installation shall be carried out in accordance with the general specification for electrical work.

- II. Attending to electrical complaints in the 02 nos. of Flood Light in Hockey fields & Street Light at Central Regional Centre for Sports Authority of India at Bhopal, one licensed wireman having domestic and overhead and industrial license and one helper will have to be provided. The electrical complaints shall be done by the staff of contractor with full satisfaction of this office.
- III. This office in charge shall be instructed to maintenance staff for attending the complaints and they will report to Regional Director or authorized officer by Regional Director, SAI CRC Bhopal.
- IV. Work related to repair/replacement of flood light lamp, capacitor igniter and other related spares and preventive maintenance of flood light installation carried in SAI premises.
- V. The defective/ replaceable material will be supplied by the contractor, make of material with strictly be used as per attached approved list of electrical material and full satisfaction of Engineer in charge.
- VI. The unserviceable/ burnt electrical material shown to Authority in charge after that returned to the contractor.
- VII. The SAI, RDCC Bhopal shall maintain a complaint register to keep up the record of complaint and rectifications, as well as to maintain instruction given by Regional Director / Authorized Officer and their compliance.
- VIII. Contractor shall also maintain for register to keep up the record of electrical material used and issued to the staff with verification of Regional Director / Authorized Officer SAI CRC Bhopal.
- IX. Contractor shall have to make arrangement for absolute checking of electrical installation before to start the games or activities and shall kept in order with full satisfaction of officer in Charge/ Regional Director.
- X. Contractor shall instruct to each wireman to keep the tool kit useful in the workmanship work which shall be arranged by the contractor.
- XI. Contractor shall be responsible for the rectification of complaints as received specially of electrical fittings within the stipulated time period.
- XII. The General preventive periodically maintenance of all electrical installation shall be done by the contractor which shall be come under scope of work.
- XIII. The General T&P equipments such as ladders, Maggers, earth tester etc. are arranged by the contractor as and when required and ladder above 8" high and other special equipment shall also be arranged by the contractor.
- XIV. The contractor shall be responsible for any damage and shall have to rectify goods to its original shaped, description as and when theft etc. is noticed or taken place due to the wrong operation of the equipments or negligence of contractor's staff.
- XV. ***In case the services deployed are found unsatisfactory then there will be a deduction of 5% on the first occasion, 10% on the second occasion and 15% on the third occasion out of the monthly bill payment which will be without prejudice to any other right of the SAI. Thereafter SAI reserves the right to terminate the contract or imposition of penalty as deemed fit for unsatisfactory services.***

- xvi. The Contractor shall have required number of caution boards such as man or Line, Don't switch on for displaying on the working place while undergoing repair works.
- xvii. The contractor shall take over the electrical installation before commencement of the work and make over the same at the time of completion of contract in original condition.
- xviii. The underground cable is excluded from the above scope of work.

(B) Non comprehensive Maintenance of other electrical installation:

- I. Maintenance of 33 KV electrical substation on regular basis.
- II. Maintenance of all domestic installation uninterrupted supply change of fittings & electric fixtures of all hostels, multipurpose hall, office premises & change room.
- III. Ensure the uninterrupted electricity supply to all staff quarters.
- IV. The successful bidder have to maintain complaint register for electrical faults and if any attachment is out of service the salvage should be deposited in the store before change of any article.
- V. A comprehensive rate list of all electrical attachment like bulb, tube light, switch, fan, repairing of fan, condenser, MCB of different power, wire, cable etc **as per Annexure-VII. The guarantee & warranty of all the items should be separately mentioned in the Annexure-VII.**
- VI. The bidder should also maintain all the inverter placed at different places of the premises.
- VII. The Generator backup its operation & maintenance is also part of this scope of work. The successful bidder will maintain a logbook for fuel consumption during operation of Generator backup and will get counter sign by Office Incharge.
- VIII. At least one electrician & helper should remain on duty 24 hours and seven days of weeks.

The wages for engaged of electricians will be as per minimum wage act applicable at MP or Central Government of India Minimum Wage Act-1948. The engagement of electrician will be at per contract labour Abolition & Regulation Act-1970.

- 7. That the successful tendered shall be the sole and principle employer of all their staff and labour employed by them and shall be responsible for observing and convey with all the employment regulations, labour laws and other laws as applicable and laid down in this behalf from time to time, in respect all the employees during the period of this agreement.
- 8. In case of any dispute between the employees and successful bidder, SAI will have no responsibility and shall not be responsible for any compensation in any form to such employment to any of such employees during the currency of and/or after the expiry of this agreement.

9. In case of any dispute the matter shall be decided by sole arbitration of an arbitrator nominated by Incharge, SAI Central Regional Centre Bhopal and the said decision shall be final and binding. It will be governed by latest arbitration act as applicable. There should be no objection that the appointed arbitrator has been associated with SAI or has been associated with the work at any stage. In case any arbitrator is removed by the court or becomes incapable of acting, then unless Incharge, SAI Central Regional Centre Bhopal appoints another arbitrator then arbitration clause shall stand superseded.
- 10. The agency will submit the bill for the maintenance of flood light in synthetic hockey field & street light and non comprehensive maintenance of all electrical installation to the Regional Director, SAI, CC, Bhopal by the 2nd of every month for proceeding month after verification by the officer deputed by him for the same. The payment of the bill be made by 6th to 8th of each month as far as possible through e-transfer in favour of the agency if services are found satisfactory and all required documents are enclosed.**
11. The Electrical maintenance work is required on all days including holidays during the month, In case if any function or event is organized in the SAI premises and the same involves additional work, then the payment will be made on 'Pro-rata basis' prevailing daily wages rates.
12. The successful tendered shall be responsible for ensuring the safety of the persons, building structures, boundary wall and open areas etc. In case of any injury to any persons or damages caused to the property of SAI or any third party, the tendered shall be responsible to pay compensation for such injury and or/damages as may be required under the law.
- In case of any court cases or challan by the police or any local authority or any other party competent to take such action, the tendered shall be solely responsible for defending the cases in a court of law and /or to ensure compliance with the summons or challan so served in this behalf.
13. Any damage done to the electrical installations and buildings by the employees of the tendered, will have to be repaired accordingly.
14. The successful tendered shall be responsible for obtaining any permission license, order of the authorities competent to grant/issue the same for the purpose of electrical installation **including flood light**. The successful tendered shall be responsible for all payment and fees for such permissions/license payable the competent authorities and shall also be liable for payment of all damages/fines or any other charges which may be levied by any authority for breach of any laws by laws regulations orders etc. issued by such authorities.
15. The successful tendered shall be responsible for fulfilling all the statutory provisions of all the labour laws of the Union as well as the State and to payable mandatory dues to Govt. like SERVICE TAX and TDS etc. will be deducted while passing bills.
16. The areas of deployment can be altered depending on need and as decided by the Regional Director, SAI, Bhopal.
17. In case of breach/non fulfillment of any of the conditions, the Regional Director, SAI Bhopal shall be entitled to terminate the contract with the one month notice to the tendered.

- 20. The currency of this contract shall be for one year which will be extended for another year subject to satisfactory execution of agreement for which no revision of agreed rates is applicable.**
21. The EMD will be returned to unsuccessful bidders within one month of the date of approval of the successful bidder. The EMD of the successful tendered will be liable to be forfeited , if he does not fulfill any of the following conditions:
