Should be super scribed on the top left corner of envelope bearing the name and address of the tendered. The sealed Tenders Enquiry should accompany the following:-
 - A. EMD amount of **Rs.1,00,000/- (Rupees one lac only)** through crossed Demand Draft drawn in favour of the Regional Director, Sports Authority of India, Bhopal payable at Bhopal. **(To be submitted in Envelope -A)**.
 - B. Tender documents duly signed by tenderer having name of tendered/Brand along with list of samples of equipments as per performs at **Annexure” I” (Envelop-B)**.

In case of delay in supply/ non supply/ short supply/ poor quality of any other complaint, SAI reserves the right to adjust extra liabilities from the Earnest Money/Security Money, disapprove a brand/all brands or may take any other action as deemed fit.
The submitted/quoted brand should be approved by International Boxing Federation & documentary evidence must be enclosed.
13. The Tender Enquiry documents are neither transferable under any circumstances.
14. The issuing of Tender Enquiry documents shall not constitute that the tendered gets automatically qualified.
15. If even after approval, information/ facts submitted by a tendered are found misleading/incorrect/false etc., SAI reserves right to disapprove an item (s) for the current/ future rate contract or may impose penalties as deemed fit. Non compliance of any of the terms of Tender Enquiry and future instructions by Incharge, SAI Central Regional Centre, will also warrant above penalties.
16. The tendered are to submit an undertaking to the effect that the samples submitted are as per specification at **Annexure II-B** of this tender, and any discrepancy found later on, the whole amount will be recoverable from the Security Money deposited.
18. The sports equipments mentioned at **Annexure-I** should be as per specification and standard laid down by the concerned National/International Federation/Association. The tendered are submit an undertaking to the effect that the rates quoted for each equipment are as per specification at Annexure II-B of this tender and any discrepancy found later on the whole amount will be recoverable from the security Money deposited.
19. These are only proposed draft terms and conditions and can be modified, changed or added to at the time of finally concluding and signing the agreement.
20. The equipments must be supplied 35 days (five weeks) after received of supply order.

23. 24. 26. All tenderer are required to mention the Name of firm and Brand name on each sample and all the samples containing discipline wise Polly thin envelops must be submitted in a sealed bag/box which will be opened and counted in front of the tendered along with Technical bid.
27. In case of supplier exclusively supplies the sports Equipment items as per this tender, the authority/certificate in this regard may be enclosed with the Tender.
28. The detail of documents required for eligibility is given in **Annexure – II**.
29. Tender Enquiry received without the above documents will summarily be rejected.
30. In case of delay in supply by the stipulated date, Regional Director, SAI Central Centre, Bhopal reserves the right of imposing penalty as deemed fit.
31. **Sales Tax/VAT and transportation charges should be included in the quoted rate. No extra charge will be paid. Custom Duty Exemption certificate will be issued by this office if required.**
32. Payment will be released after one week of satisfactory supply and receipt of goods, supplied as per supply order.
33. The manufacturer/ supplier should give minimum guarantee of one year in case of Sports Equipments items for material manufacturing defects, and undertake to replace defective products at no extra cost within a month of the defect being brought to notice of the manufacturer/ supplier.
34. The supply order can be terminated or cancelled summarily by SAI in whole or in part any time without assigning any reason, if the supply made by the manufacturer/ supplier is not found according to the sample approved or in case supply is not received within stipulated time, and Regional Director, SAI Central Regional Centre, Bhopal feels that it cannot be used for the event/camp/practice for which it was requisitioned.

38. The venue of such arbitration proceedings shall be at Bhopal or as decided by Director General of SAI and the courts in Bhopal alone will have Jurisdiction in respect of all proceedings connected there with.
39. Sales tax and transportation charges will be on actual basis and SAI reserve right to verify freight charges, from market and in case of difference is found SAI rate will prevailed.
