- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. #### 1. Generic

Bidders are bound to accept the orders accordingly.

#### 2. Generic

#### 3. Service & Support

# GENERAL SPECIFICAITONS FOR ABOVE ITEMS

**Egg** – Egg should be clean and have intact shell. The old stock should not be supplied. During supply, the broken Eggs, if any shall be replaced immediately.

**Chicken** – The quality of Chicken boneless/Chicken Sausages/Salami & live must be of best quality and free from all kind of diseases.

**Goat Meat** – The Meat shall be the produce of healthy and well-nourished stock which has been passed as fit for slaughter by municipality slaughter officer. The weight of the Goat should be between 06 Kg. to 09 Kg.

**Fish** – The fish cleaned should be fresh and free from any water bound diseases. Fish should have intact gills. It should be bright and pink in color.

- (1) As per the list of items the bidder is requested to submit the rate for per KG and per PCs and the total of rate lumpsum amount may also be calculated and submitted in the BOQ. The total quantity of the items as mentioned in the list will be intimated after the finalization of the contract and day to day supply of Non-Veg items depend on total NCOE Athletes / Campers. The bidders also required to submit the FSSAI certificate All India or UP for supply of Non-Veg items.
- (2) All the above mentioned items will delivered FOC at Consignee Location.
- (3) The bidder will be considered L-1 whose overall quoted rates for all the items mentioned in the

ATC sl. No. 01 to 47.

- (4) It is mandatory for bidder to quote the rates in financial document only.
- (5) Successful bidder is required to submit the invoices separately against supply order placed from time to time.
