1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

Terms and Conditions:

1. Service provider is required to pay Salaries/Wages of contracted staff deployed at buyer location first i.e., on their own which can be up to Three months and then claim payment from Buyer along wit h all statutory documents like PF, ESIC Challan etc. as well as the bank statement of salary to staff. Th e service provider should not make any other deductions such as contribution to society, caution depo sit etc. other than the statutory deductions.

2. Should have registered/corporate/Branch office in Consignee Location for quick response.

3. The Bidder should provide Contract labor license for providing Security Guards Guards s ervice as per the CLRA Act 1950 from Shram Suvidha portal or Maharashtra Contract labour (Regulation and Abolition) Act, 1971. They should submit copy of Shram Suvidha CLC Annual Return in case of CLRA Act 1950. The bidder must provide license under PSARA act 2005.

4. Copy of Annual Turnover not less than 40 Lakhs for last 3 years Last Three Years Turnov er Certificate.

5. Bidder must ensure the submission of similar work order from any of the state/ce ntral government organizations.

- 6. Solvency Certificate minimum 30 lakhs from Bank (Not above Six Month)
- 7. Should furnish valid ISO Certificate for providing <u>Security Guards</u> services.
- 8. Should have minimum 3 years 'experience in providing <u>Security Guards</u> services.

9. Should submit minimum wages compliance certificate from the current client stating that t he contractor is paying wages in accordance with minimum wages notified by the Chief Labour Commissioner Central to the employees engaged in various day-to-day activities.

10. Should submit proof of remittance of ESIC, PF, GST, etc.

11. Should have registered under GST Act.

12. ITR for past 03 years along with balance sheet and Profit & Loss Statement (F.

Y19-20, F.Y. 20-21 & F.Y. 21-22)

13. Current client list with contact details.

14. The service provider is required to have at least 50% of the required <u>Security Guards</u> S ervice provider Payroll for at least one year. Necessary documents relating to such <u>Security</u> <u>Guards</u> Service will be uploaded by the bidder for verification of the Buyer.

7. Purchase Preference (State)

Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority whose credentials are validated online through UDYAM Registration /Udyog Aadhaar (as validated by Government from time to time) for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Benifits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 8. Seeking sample with bid or approval of samples during bid evaluation process.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
