The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. During the CMC period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee as recommended in the manufacturer's technical/ service /operational manual, at least once in six months or as per requirement. 5. The payment of CMC will be made on quarterly basis after satisfactory completion of said period, duly certified by user.

6.While creating a bid or RA, buyers shall indicate whether CMC is required against Yes/No" options. If 2 year warranty specified, n shall be2 and if 5 year warranty specified, n shall be 5. A1,A2, A3, A4& A5shall depend on how many years CMC selected. For3 yearCMC, only A1,A2 and A3 factors are to be taken into accurate and A4 and A5 will not be applicable.

8.4.CMC charges offered for each subsequent year should be same or higher than preceding year.

8.5.The CMC charges shall be offered within range of 3 to 10% of cost of equipment.

9. Since CMC charges are to be paid only later for each year during CMC period, applicable performance guarantee amount after placement of contract shall be based on the cost of equipment excluding the cost of CMC Charges.
