4. Bidder to upload an undertaking stating that they agree to all the enclosed and mentioned terms and conditions of the bid.
5. Bidder to upload an undertaking stating that they have filled the rates of all the items mentioned in BOQ. Non-compliance for the same will result in disqualification of the bidder.
6. Bidder is required to fill and upload all the documents (as per the given format) mentioned in Buyer uploaded ATC Document. If Bidder fails to upload any documents will be considered as un-responsive bidder.
7. The consignee address for the items may be as per the ATC document attached.
8. No CDEC will be provided.
9. A detailed catalogue for each product must be submitted, including product information and compliance details.
10. Transit insurance should be covered by supplier.
